City Manager Dean Albro presented a brief video highlighting the Lompoc Electric Division; announced the Lompoc Public Library is hosting a Tiny Art Showcase Reception in the Grossman Gallery on Saturday, October 5, 2022 from 4pm to 5pm; asked Council to confirm if they want Staff to return at a future meeting with an item to allow for Council discussion and possible action regarding compensation for Council Members. With a general consensus, Council approved a future agenda item to discuss and take possible action on the compensation for Council Members.

City Attorney Jeff Malawy presented a brief report to Council regarding the recent lawsuit against the City from the citizens group Environmental Defense Center.

Council thanked Staff for the video presentation and the report on the lawsuit.

Adoption of Resolution No. 6548(22) Authorizing Participation in a Memorandum of Understanding with the County of Santa Barbara, and the Cities of Buellton, Carpinteria, Goleta, Santa Barbara, and Solvang to Share the Cost of Continuing the Revised Santa Barbara County Regional SB 1383 Food Recovery Plan Extension.
