WHEREAS, the City of Lompoc (City) operates and maintains the Lompoc Municipal Waste Facility (Landfill) at the end of Avalon Road in the southwestern most corner of the City; and

WHEREAS, the City seeks to implement precipitation and drainage controls to satisfy the requirements of the Central Coast Regional Water Quality Control Board (RWQCB) specific Notice of Violation requirements and general construction criteria and specifications stipulated by Title 27 of the California Code of Regulations, Environmental Protection; and

WHEREAS, staff and its consulting team completed the Lompoc Landfill Drainage Improvements Project (Project) design, received construction bids, and received construction management inspection and testing proposals for the Project; and

WHEREAS, the City Council desires to complete the Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Plans and Special Provisions for Project No. FY-20-LF-1 are hereby adopted, as required by Section 22039 of the Public Contract Code. Copies of the Plans and Special Provisions are on file in the City Engineer's office.

SECTION 2. The construction contract (Contract) for the Project in the amount of \$5,489,550 is hereby awarded to Bosco Constructors, Inc., in a form approved by the City Attorney.

- a. The City Manager is authorized to execute the necessary agreements for the Contract:
- b. The Solid Waste Superintendent, or designee, is authorized to approve additional construction costs and construction contract change orders for the Contract in an amount not to exceed \$800,000.

SECTION 3. The consulting contract for construction management, inspection, and construction materials testing services (Construction Management Contract) for the

Project is hereby awarded in the amount of \$603,410 to MNS Engineers, Inc., in a form approved by the City Attorney.

- a. The City Manager is authorized to execute the necessary agreements for the Construction Management Contract;
- b. The Solid Waste Superintendent, or designee, is authorized to approve additional costs and contract change orders for the Construction Management Contract in an amount not to exceed \$80,000.
