## **RESOLUTION NO. 6570(23)**

A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Approving Supplemental Appropriations and Supplemental Revenues Pursuant to the Partnership with the Housing Authority of Santa Barbara County and Flock Group, Inc., to Provide 38 Flock License Plate Reading Cameras Throughout the City

**WHEREAS**, on March 21, 2023, the City Council approved the Partnership with Santa Barbara County Housing Authority (Hasbarco) and the Flock Group, Inc. (Flock) for the installation and maintenance of 38 Flock License Plate Reading (LPR) cameras at various locations as determined by Hasbarco throughout the City; and

**WHEREAS,** on March 21, 2023, the City Council approved a Service Agreement with Flock for Installation and Use of License Plate Readers; and

**WHEREAS,** on March 21, 2023, the City Council approved a reimbursement agreement with Hasbarco to reimburse the City's costs under the service agreement with Flock; and

WHEREAS, the City will pay Flock the initial contract term of two years, with automatic renewals for unlimited successive two-year terms. The Initial payment to Flock Group Inc. is \$203,300.00 for the first two-year period and the following reoccurring two-year subscription term payments are \$95,000.00. Hasbarco will reimburse the City of Lompoc for the initial \$203,300.00 for the first two-year period and subsequent payments of \$95,000.00 for the subsequent two-year periods until they no longer wish to use the LPRs at which time both agreements will be terminated and the LPR cameras dismantled by Flock; and

**WHEREAS**, the City Council now desires to appropriate funds for the completion of the project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** To approve budget appropriations for the project from the Supplemental Revenue to the Supplemental Appropriations as follows:
