# **PRESENTATIONS:**

 Update on Parks Projects – Oral Report by Mario Guerrero, Jr., Parks and Recreation Manager

Mario informed the Commission that Jason Rojas, Parks and Recreation Project Coordinator is no longer with the City of Lompoc and the position is posted on the website and will close on Friday. He then provided an update on new and upcoming renovations occurring at city parks which included:

- The Lompoc Aquatic Center will be closed due to Competition Pool heater being replaced and having to replace the gas regulator as it malfunctioned when replacing the Therapy Pool and Activity Pool heaters
- Thompson Park project completed
- Ryon Park replacement of playground and ADA fitness center, refresh four tennis courts and replacing the others with a pickleball court. Hoping to break ground in 8-10 weeks
- River Park refurbishing old RV camp sites
- Pioneer Park new playground, adding fitness area, and renovating the baseball field
- Centennial Square general landscaping, adding irrigation, and a new monument sign
- Library all new landscaping, upgrade outdoor patio area and redo parking lot

 College Park – project with RHA, meeting with Planning to go over submittals, hoping to be on Planning Commission by June and be out to bid and awarded by the fall

Commissioner Burns asked who uses Pioneer Park. Mario replied Babe Ruth during their league and fall ball seasons. Commissioner Baker asked what the timeline was for the pickle ball courts and if the pickle ball users would be able to use LVMS tennis courts in the meantime. Mario replied there was no timeline as of yet, they are waiting to meet with the company that is awarded the project but hoping to break ground in May/June and be completed by September. He continued to say that the LVMS tennis courts are in bad condition but ran through the school district.
