WHEREAS, the Regional Water Management Planning Act (SB 1672) was passed by the California State Legislature in 2002, creating the Integrated Regional Water Management (IRWM); and

WHEREAS, the City of Lompoc (City) adopted the County of Santa Barbara's Integrated Regional Water Management Plan in 2007, by action of City Council, and has continued to participate as a Cooperating Partner on the actions described in the County's IRWMP, managed by the Santa Barbara County Water Agency (SBCWA), since; and

WHEREAS, the Department of Water Resources issued the Proposition 1 Round 2 Integrated Regional Water Management Implementation Grant Program solicitation in May of 2022; and

WHEREAS, the SBCWA, on behalf of the City, requested, and was awarded, \$449,993 from the Proposition 1 Round 2 Integrated Regional Water Management Implementation Grant Program; and

WHEREAS, the City desires to accept the grant award of \$449,993 to fund supply-side water leak detection and repair activities, and supplement the existing demand-side Water Leak Detection and Repair Rebate Program offered by City's Utility Department.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Manager or designee is hereby authorized and directed to execute all documents necessary to receive a subgrant award of \$449,993 from the SBCWA to reimburse expenses incurred for supply-side water leak detection and repair activities and the Water Leak Detection and Repair Rebate Program; and

SECTION 2. The City Manager or designee is hereby authorized and directed to utilize water retrofit proceeds to fund supply-side water leak detection and repair activities, and supplement the existing demand-side Water Leak Detection and Repair Rebate Program offered by City's Utility Department; and
