

**RESOLUTION NO. 6605(23)**

**A Resolution of the City Council of the City of Lompoc,  
County of Santa Barbara, State of California,  
Affirming the Mural Project as a City Project;  
Authorizing the City Manager to Execute  
Site and Artist Agreements for Approved Mural Sites;  
Approving 18 Mural Sites Not Previously Approved**

**WHEREAS**, in 1988 the City of Lompoc (City) developed a Mural Project for the purpose of displaying the history and culture of the community in a series of murals mounted on buildings in the City; and

**WHEREAS**, on September 20, 1989, on a 3-1 vote, the City Council accepted the Lompoc Mural Project (Project) as a City Council project, permitting the Project to apply for a funding grants, with the understanding that whenever significant money was to be spent for the project, that item would be brought to the City Council, prior to the expenditure of funds; and

**WHEREAS**, on October 3, 1989, the City Council adopted Resolution No. 3887(89), authorizing the City Administrator to execute site and artist agreements for the Project, limited only to sites approved by the City Council; and

**WHEREAS**, on April 2, 1991, the City Council adopted Resolution No. 4036(91) authorizing the City Administrator to execute Site and Artist Agreements for the Project, limited to sites within the scope of the Project, as previously approved by City Council action, adding seven additional sites; and

**WHEREAS**, on March 6, 2001, the City Council approved four mural sites; and

**WHEREAS**, on December 3, 2002, the City Council approved eleven mural sites;  
and

**WHEREAS**, on February 1, 2005, the City Council approved seven mural sites;  
and

**WHEREAS**, on May 16, 2006, the City Council approved eight mural sites; and

**WHEREAS**, an additional 18 mural sites have been designated by the Mural Society and Site Agreements have been signed for those sites without approval by the City Council; and

**WHEREAS**, the City Council now wishes to reaffirm the Mural Project as a City Project, and approve those 18 additional mural sites.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The Lompoc Mural Project established on September 20, 1988, as a Lompoc City project, is affirmed to remain a City Project.

**SECTION 2.** The City Manager is authorized to sign Mural Site Agreements and Artist Agreements in a form to be approved by the City Attorney, for any site that has been approved by the City Council.

**SECTION 3.** Eighteen additional mural sites (the sites listed in Exhibit A hereto without Means of Approval listed) are hereby approved.

**SECTION 4.** The list of mural sites attached hereto as Exhibit A is hereby approved by the City Council as official sites for the Lompoc Mural Project.

**SECTION 5.** Effective Date. This Resolution is effective on the day of its adoption.
