14,000 Human Services Donation Flyers were printed and paid for by CDBG in the amount of \$1,332.19. The flyers requesting donations for the Human Service Fund will be distributed with the City of Lompoc July Utility Invoices.

The Commission's request to city council for \$30,000 for each Fiscal Year for budget 2023-25 (total of \$60,000) for the Human Services Fund was granted.

City administration is anticipating the 2024-25 CDBG Grant allocation from Federal Government to be significantly less than the previous year.
