## **CONSENT CALENDAR:**

1. Adoption of Resolution No. 6602(23) to Close City Hall and Suspend Certain Field Operations from December 27 to December 29, 2023.

2. Approve Memorandum of Understanding Between the City, the Lompoc Valley Community Healthcare Organization, and Lompoc Unified School District for Funding and Completion of the Non-Infrastructure Portion of FY-23-S-1 City of Lompoc Walkability, Safety And School Investments Project

Approved the Memorandum of Understanding (MOU) establishing a partnership between the City, the Lompoc Valley Community Healthcare Organization (LVCHO), and Lompoc Unified School District (LUSD) for the funding and completion of the Non-Infrastructure portion of City of Lompoc Walkability, Safety And School Investments Project; and authorized the City Manager to execute the MOU.

#### STAFF PRESENTATIONS/ANNOUNCEMENTS/REQUESTS:

• Park & Recreation Project Coordinator Jim Mindoro provided a brief update on the current projects at certain City parks and facilities.

Council Member Starbuck asked Staff if there is a timeline for rehabilitation or replacement of the stage at Ryon Park and if the rehabilitation and repair of the parking lots at Beattie Park have been completed. Parks & Recreation Manager Mario Guerrero stated the parking lots at Beattie Park are scheduled to be reopened at the end of October and explained there are three options provided by Staff for the stage at Ryon Park in the Capital Improvement Program, but a project has not yet been funded.

 Utility Director Charles Berry provided a presentation on the State of California's Cap and Trade Program – the market-based emission trading system setup to help reduce greenhouse gas emissions.

Council thanked Mr. Berry for this information and discussed possible uses for the money available to the City through the State of California's Cap and Trade Program.

- 3. Steve Popkin, representative from Lompoc Valley Medical Center Hospital briefly spoke about the person found deceased outside of the hospital and invited the public to reach out to the hospital with any questions or concerns regarding this matter.
- 4. (Via Phone), (Name not provided), asked for the City to address her concern about the condition of streets in certain parts of the City, specifically the housing tract behind the Albertson's shopping center.
