## **RESOLUTION NO. 6619(23)**

A Resolution of the Council of the City of Lompoc,
County of Santa Barbara, State of California,
Approving Fiscal Year 2023-24 City of Lompoc HOME Consortium
Funds to be Allocated to the Housing Authority of County of
Santa Barbara for a Lompoc Tenant-Based Rental Assistance Program

**WHEREAS**, the HOME Investment Partnerships Act under Title II of the Cranston-Gonzalez National Affordable Housing Act of 1990 (42 U.S. Code sections 12703 *et seq.*) was enacted for the primary objective of increasing the supply of decent affordable housing to lowand very low-income residents; and

**WHEREAS**, 24 Code of Federal Regulations 92.101 provides direction under HOME Investment Partnerships Program (HOME) for contiguous units of general local government to join together and form a consortium; and

**WHEREAS**, the County of Santa Barbara and the cities of Lompoc, Santa Maria, Goleta, Carpinteria, Buellton, and Solvang, not being individually eligible for formula allocation, desire to cooperate and participate in a consortium for purposes of receiving HOME funds and promoting affordable housing; and

**WHEREAS**, the City of Lompoc (City) first started participating in the Santa Barbara County HOME Consortium in 1997; and

**WHEREAS**, it is the desire of the City to allocate its portion of Fiscal Year 2023-24 HOME Consortium Funds in the amount of \$123,933 to the Housing Authority of the County of Santa Barbara (HASBARCO) for a Lompoc Tenant-Based Rental Assistance (TBRA) Program that will provide onetime security deposits on behalf of low-income households to secure decent, safe and sanitary housing in Lompoc.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** The City approves its portion of the Fiscal Year 2023-24 HOME Consortium Funds in the amount of \$123,933 to be allocated to HASBARCO for a Lompoc TBRA Program.

**SECTION 2.** The City Manager or his/her designee is hereby authorized to execute any and all documents necessary to coordinate the City's portion of the Fiscal Year 2023-24 HOME Consortium allocation to HASBARCO to administer a Lompoc TBRA Program.
