## **RESOLUTION NO. 6624(23)**

A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Adopting The City of Lompoc Local Road Safety Plan, December 2023

WHEREAS, the City was awarded a funding grant for \$72,000 to prepare a Local Road Safety Plan (LRSP), and the City subsequently executed a grant agreement with the State; and

WHEREAS, the City contracted with GHD, Inc. for the preparation of the LRSP; and

**WHEREAS**, the Plan is being created for the purpose of complying with new state and federal requirements related to the Highway Safety Improvement Program (HSIP); and

**WHEREAS**, a Local Road Safety Plan (LRSP) is a road safety planning document that provides a holistic analysis of vehicle, pedestrian and bicycle crash data, and provides a roadmap for implementation of safety improvements; and

**WHEREAS**, it is required that all state, county, and local agencies adopt an LRSP to be eligible to receive Highway Safety Improvement Program (HSIP) and other grants such as Safe Streets and Roads for All (SS4A); and

WHEREAS, the LRSP was developed using public outreach and the process outlined by Caltrans to facilitate a systematic approach to providing safety improvements and guide the City to set goals and measures that encourage a safe, well-connected transportation network for people using all modes of transportation, and the LRSP prioritizes safe travel of people as well as expeditious travel of motor vehicles, seeking to achieve zero roadway fatalities and serious injuries by the year 2050; and

**WHEREAS**, the Plan has been developed through the coordinated efforts of City staff, the consultant, a stakeholder working group, and input from the public through an online engagement; and

**WHEREAS**, the City Council has reviewed and considered the staff report and the Local Road Safety Plan presented at the meeting on December 19, 2023.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

- **SECTION 1.** The City of Lompoc Local Road Safety Plan, December 2023 (2023 LRSP) (attached to the staff report accompanying this resolution as Attachment 1), is hereby adopted.
- **SECTION 2.** The submittal of the 2023 LRSP to the State of California is hereby authorized.
- **SECTION 3**. Effective Date. This Resolution is effective on the day of its adoption.
