**Appliance Recycling:** Refrigerators or Freezers may be recycled at the City of Lompoc (City) Landfill. A disposal receipt is required from the landfill for the disposal rebate. The City will take the old appliance to the landfill at no cost. Application must be submitted first to schedule an appliance pickup. Call the City of Lompoc Conservation Division at 805-875-8252 to schedule a bulky item pickup. Allow up to 3 weeks for removal. Place appliance out where your regular refuse is placed before 7:00 am on the scheduled pickup day. To be hauled away, all doors must be sealed with duct tape and appliances must be empty. Appliances may also be recycled though the retailer. Confirmation will have to be documented on the receipt as recycled.
