# **PRESENTATIONS:**

1. Update on Parks Projects – Oral Report by Mario Guerrero, Parks and Recreation Project Coordinator

Mario Guerrero provided an update on the following projects:

- Ryon Park Tennis Courts and Pickleball Courts are 99% completed. Waiting on two new light poles. Due to the weather, there has been surface issues and staff is working with the contractor to get those fixed.
- Anderson Recreation Center HVAC project's RFP has been posted online
- The Lompoc Aquatic Center's Dehumidification system project was awarded to Smith Electric. Waiting for the PO to get a better timeline.
- Roof panels are scheduled to be installed in February
- College Park project is awaiting to go out to bid
- Beattie Park basketball court lighting getting updated to LED lights by RARE Electric
- Staff continues to meet with Babe Ruth on volunteering with Pioneer Park renovation project
- JM restroom will be completed in July or August
- Waiting on cost estimate to redo restrooms at Ryon Park. Hoping to get those completed by the fall if funding is available.

Commissioner Burns asked if the pickleball courts are under warranty. Mario replied yes, but looking into what actually caused the bubbling. Commissioner Baker inquired on the timeline for Babe Ruth renovations. Mario replied the

playground will be late spring and the fencing will depend on funding but, it should not impact the season.
