SUBJECT: Award of Contract for Request for Proposals No. 3016, Land Mobile Radio

System Design, Purchase, and Installation to EF Johnson Company; Adoption of Resolution No. 6640(24) Appropriating Funds for the Project

Recommendation:

Staff recommends the City Council:

- Award Contract for Request for Proposals (RFP) No. 3016 Land Mobile Radio System (Project) to EF Johnson Company (EF Johnson), in the amount not to exceed \$3,976,569.06 (Attachment 1);
 - a. Authorize the City Manager to execute the necessary agreements for the Project;
 - b. Authorize the Public Works Director to approve change orders in an aggregate amount not to exceed 10%; and
- Adopt the plans and specifications for the Project as required by Section 22039
 of the Public Contract Code (copies of Plans and Special Provisions are on file
 in the Public Works Department Office).
- 3) Adopt Resolution No. 6640(24) (Attachment 2) appropriating funds for the Project.

Background:

In April 2022, staff brought to the City Council the need to replace the City's aging radio network system which provides the essential communications for our first responders and other City crews. At that time the City Council adopted Resolution 6486(22) which provided \$2,500,000 of project funding to cover the estimated project cost.

Staff contracted with Z Consulting (Consultant) in June 2022 to conduct a comprehensive system needs evaluation and to assist with the preparation of technical specifications and performance measures for the preparation of bid documents.

Discussion:

The RFP was noticed and advertised by the Purchasing Division on November 14, 2022, and closed on March 15, 2023. The City received four proposals from qualified bidders. With the assistance of the Consultant, an evaluation committee evaluated the four proposals on the criteria listed in the RFP (20% Proposed System Design; 20% Project Management, Implementation, and Migration; 10% Financial Stability; 5% References; 20% Interviews; 15% Cost; and 10% Vendor's Overall Response). Based on the criteria, EF Johnson was ranked highest. Each bidder, with the scoring committee's corresponding score (out of a total possible 100), is listed in the Notice of Intent to Award (NOI) (Attachment 3).

As allowed in the RFP, subsequent to posting the NOI and prior to award the City and EF Johnson have further refined their proposal and scope of work to best meet the City's needs and limited budget constraints. The proposed contract in its entirety is contained in Attachment 1.

The new land mobile radio system will include redesign and replacement of the existing radio system including infrastructure equipment and software; an increased level of coverage; flexibility to take advantage of future technologies; interoperability with local, regional, State, and Federal first responder agencies; and increased reserve capacity for use during major manmade or natural catastrophic events.

Fiscal Impact:

Because actual costs came in significantly higher than the previously allocated project funding, additional supplemental funding is needed to construct the Project. Project costs are identified as follows:

Supplemental appropriations are identified in Resolution No. 6640(24) to fund the additional \$2,126,569 required for the improvements. There are four general categories of funding identified which include, General (GF), Enterprise, Road, and Internal Service (IS) Funds. A summary of the cost allocation breakdown by users and fund type is provided in the following table:
