## **RESOLUTION NO. 6681(24)**

A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Withdrawing the Submission to the Qualified Electorate of the City of Lompoc a Measure, Entitled the Ken Adam Park Measure, at the General Municipal Election to be Held on November 5, 2024; and Withdrawing the City's Request that the County of Santa Barbara Consolidate the Ken Adam Park Measure with the Statewide General Election to be Held on November 5, 2024

**WHEREAS**, on May 21, 2024, by adoption of Ordinance No. 1708(24), the City Council of the City of Lompoc (City) ordered the submission to the qualified electorate of the City a measure, entitled the Ken Adam Park Measure (City Measure), at the General Municipal Election to be Held on November 5, 2024, pursuant to California Elections Code sections 306, 9222, and 1301, and Government Code section 38450; and

**WHEREAS**, also on May 21, 2024, by adoption of Resolution No. 6656(24), the City Council requested the City Measure be consolidated with the Santa Barbara County General Election to be held on November 5, 2024; and

**WHEREAS**, on July 2, 2024, the City Council ordered the submission of a qualified citizen initiative measure (Citizen Measure), that would have the same main legal effect as the City Measure, to the voters at the November 5, 2024, General Municipal Election, pursuant to Elections Code 9215.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** The foregoing recitals are true and correct and are hereby incorporated and made an operative part of this Resolution.

**SECTION 2.** Pursuant to Elections Code 9605 or any other legal authority, the City Council hereby withdraws Ordinance No. 1708(24) and its submission of the City Measure to the voters at the November 5, 2024, General Municipal Election, and hereby withdraws Resolution No. 6656(24) requesting consolidation of the City Measure with the Santa Barbara County General Election, and hereby withdraws Resolution No. 6657(24) directing the City Attorney to prepare an impartial analysis of the City Measure and setting arguments for the City Measure.

**SECTION 3**. This Resolution shall become effective upon its passage and adoption, and the City Clerk is directed to send certified copies of this Resolution to the Santa Barbara County Board of Supervisors, to the County Clerk-Recorder, and County of Santa Barbara Election Department.
