

City of Lompoc Cannabis Taxes: Filing and Payments

Retail Operations Tax Return

- If you sell cannabis or cannabis products, you are required to file monthly tax returns to report your sales. If you have no taxable transactions to report, you are still required to file your tax return. The current retail operations tax rate is 6%.
- You can file your cannabis tax return and make payments with the City of Lompoc Treasury Department located at 100 Civic Center Plaza, Lompoc, CA 93436.
- If you will be paying your taxes with cash, an appointment will need to be made with the City of Lompoc Finance Department at (805) 875-8239. The appointment needs to be made by the 15th of each month.
- If you will be paying with a check or money order you do not need an appointment. Please submit your return and payment to the Treasurer's office by the due date on the return.
- If the taxes are paid after the due date a 25% delinquent fee & interest will be assessed.

Manufacturing and Distribution Tax Return

- If you manufacture, process and/or distribute cannabis or cannabis products, you are required to file monthly tax returns to report your sales. If you have no taxable transactions to report, you are still required to file your tax return. The current tax rate for manufacturing/distribution is based on the annual gross sales receipts.
- You can file your cannabis tax return and make payments with the City of Lompoc Treasury Department located at 100 Civic Center Plaza, Lompoc, CA 93436.
- If you will be paying your taxes with cash, an appointment will need to be made with the City of Lompoc Finance Department at (805) 875-8239. The appointment needs to be made by the 15th of each month.
- If you will be paying with a check or money order you do not need an appointment. Please submit your return and payment to the Treasurer's office by the due date on the return.
- If the taxes are paid after the due date a 25% delinquent fee and interest will be assessed.

Cultivation Tax Return

- If you cultivate cannabis or cannabis products, you are required to file monthly tax returns to report your sales. If you have no taxable transactions to report, you are still required to file your tax return. The current cultivation tax rate is 1%.
- You can file your cannabis tax return and make payments with the City of Lompoc Treasury Department located at 100 Civic Center Plaza, Lompoc, CA 93436.
- If you will be paying your taxes with cash, an appointment will need to be made with the City of Lompoc Finance Department at (805) 875-8239. The appointment needs to be made by the 15th of each month.
- If you will be paying with a check or money order you do not need an appointment. Please submit your return and payment to the Treasurer's office by the due date on the return.
- If the taxes are paid after the due date a 25% delinquent fee and interest will be assessed.
