SUBJECT: Adoption of Resolution No. 6697(24) Approving Supplemental

Appropriations for City Facilities' Security System Services

Recommendation:

Staff recommends the City Council adopt Resolution No. 6697(24) (attached) which will approve supplemental appropriations in various accounts as further described in the Fiscal Impact section below.

Background:

Beginning in July 2020, the City has entered into various agreements with Secure Pro, Inc., to provide security, monitoring, alarm, and fire sprinkler system upgrades and service for the City's various properties.

Discussion:

Finance reviewed the budgets for various accounts related to the ongoing contractual services the City has with Secure Pro, Inc. Those reviews led to the discovery that the budget lines that were adopted for Fiscal Year (FY) 2023-24 were inadvertently omitted from the FY 2024-25 budget lines.

In addition, during FY 2023-24, Finance worked with the Facilities Division to create accounts for the various maintenance costs not covered under warranty that would be needed for the security equipment. Those new accounts were not originally included in the approved Biennial Budget FYs 2023-25, and will require additional allocated budget for FY 2024-25 to maintain the contracts.

The table below details the amounts needed for each account line in FY 2024-25:

Fiscal Impact:

A total of \$126,610 additional appropriations is being requested for the Building and Facilities Division accounts, which is part of the General Fund. In addition, each of the following Utility divisions is requesting appropriations in their respective fund balances. Water is requesting additional appropriation of \$22,200, Electric is requesting additional appropriation of \$22,930, Wastewater is requesting additional appropriation of \$2,500, and Solid Waste is requesting additional appropriation of \$10,000. Those utility appropriations will not impact the General Fund.

Conclusion:

In order to continue the City's agreements with Secure Pro, Inc. for security services, supplemental appropriations are needed to provide budgeted amounts to cover expenses expected to occur based on the contractual agreements.
