SUBJECT: Approval of Response to the 2023-24 Santa Barbara County Grand Jury

Report – "Homeless Encampments in Santa Barbara County; Becoming

Part of the Community Again"

Recommendation:

Staff recommends the City Council review the Santa Barbara County Grand Jury (Grand Jury) report entitled "Homeless Encampments in Santa Barbara County: Becoming Part of the Community Again" (Attachment 1) and approve the proposed response letter presented on behalf of the City, pursuant to California Penal Code Sections 933(c) and 933.05(a), (b) and (c) (Attachment 2).

Background:

Each year, the Grand Jury surveys various operations involving governmental services provided for the benefit of the residents of the County of Santa Barbara (County). The 2023-24 Grand Jury selected "Homeless Encampments in Santa Barbara County: Becoming Part of the Community Again" as an area of focus. The 2023-24 Grand Jury provided a report with recommendations for municipal agencies in the County, the County itself, and the eight incorporated cities in the County.

The 2023-24 Grand Jury published the report "Homeless Encampments in Santa Barbara County: Becoming Part of the Community Again" on June 21, 2024 (Grand Jury report). All jurisdictions noticed in the Grand Jury Report must file a response to the findings and recommendations pursuant to the above referenced California Penal Code sections within 90 days or no later than September 19, 2024. The Grand Jury report included a total of seven findings and seven recommendations. The City is required to respond to Findings 2 and 3 and Recommendations 2 and 3¹.
