Dear Lompoc Parks and Recreation Commission,

The Lompoc Tsunami Swim Team will be hosting a "Toys for Tots Swim Meet" on December 7 and 8, 2024 at the Lompoc Aquatic Center. We are inviting several swim teams from surrounding areas including: Arroyo Grande, Santa Maria, Santa Barbara, San Luis Obispo, and Carpinteria. This two-day event will provide economic benefit to the city of Lompoc by bringing many visitors to the city.

The swim meet is the annual fundraiser for the non-profit Lompoc Tsunami Swim Team. We are asking for a Parks & Recreation Commission Sponsorship of \$1,000 to assist the Lompoc Tsunami team with the city-related fees of using the Aquatic Center. If the sponsorship is awarded, the money will be used to offset the fees the City would otherwise impose for the event.

Prior to sanctioning and approving a meet, Lompoc Tsunami must submit a meet file and meet requirements to Southern California Swimming Board. The application and approval process is lengthy. The "Toys for Tots Swim Meet" was recently sanctioned and approved by Southern California Swimming and thus we were unable to meet the deadline set for the last Wednesday in May to submit the formal application. Therefore, I am writing this email to formally request a \$1,000 Lompoc Parks and Recreation Sponsorship.

The Lompoc Tsunami will be very appreciative of any support or sponsorship that the Lompoc Parks and Recreation Commission can assist. The Lompoc Tsunami will meet all of the rules and regulations required to have an event on city facilities.
