RESOLUTION NO. 6701(24)

**A Resolution of the Council of the City of Lompoc,
County of Santa Barbara, State of California,
Modifying Existing Electric Rate Schedules**

WHEREAS, the City Council of the City of Lompoc (City), when acting by resolution thereof, has the duty and power to establish the rates to be charged for the sale of electrical energy, to set up classifications and schedules for such rates, and to adopt and promulgate rules and regulations necessary for the operation of the electrical distribution system of the City and the collection of electrical charges; and

WHEREAS, the City Council has previously established by resolution the rates to be charged for the sale of electrical energy and the classifications and schedules for such rates, and has amended said schedules and rates from time to time; and

WHEREAS, the City Council now desires to further amend the schedules and rates to be charged for electrical energy.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA,
DOES HEREBY RESOLVE AS FOLLOWS:**

SECTION 1. All prior resolutions establishing electric rates are hereby rescinded.

SECTION 2. The General Conditions in Exhibit 1 hereto are hereby adopted.

SECTION 3. The rate schedules in Scenario 3 Exhibits 2 through 15, attached hereto are hereby adopted, effective with the electric bills to be mailed on and after November 1, 2024. These rate schedules represent rate increases in accordance with the following:

1. Schedule A-1 General Service
2. Schedule A-12 General Service (Demand Metered)
3. Schedule A-13 General Service (Economic
Development Incentive Rate)
4. Schedule D-1 Domestic Service
5. Schedule D-2 Domestic Service (Mobile Home Park)
6. Schedule LS-1 Street and Highway Lighting
7. Schedule LS-2 Customer Owned Street and Highway Lighting
8. Schedule OL-1 Outdoor Area Lighting Service
9. Schedule S-1 Stand-by Service
10. Schedule LS-3 Induction and LED Street Lighting

- 11. Schedule G-1 Customer Owned Generation (Distribution Rate)
- 12. Schedule NEM Net Energy Metering
- 13. Schedule PBP-1 Public Benefits Program
- 14. Schedule CUR-1 Firm Curtailable Load Purchase Rate


SECTION 2. This Resolution is effective on the day of its adoption.


