



## POOCH PLUNGE ATTENDEE AGREEMENT AND WAIVER

### I AGREE TO THE FOLLOWING TERMS:

1. I agree to practice responsible pet ownership.
2. I understand that Pooch Plunge is a litter-free event. I agree to immediately deposit any trash or dog waste in the proper receptacle.
3. I do hereby represent and warrant that my dog(s) has complete, up-to-date vaccinations and current rabies shots.
- 4. I agree not to leave my dog(s) unattended at any time.**
5. I agree not to leave my dog(s) enclosed in any vehicle.
6. I release any right and grant full permission to Pooch Plunge to use, without payment, any photographs, videotapes, motion pictures, sound recordings, or any other record or information derived from Pooch Plunge or any other related event.
7. In participating in Pooch Plunge, I recognize and acknowledge that injury, illness or damage could occur to my person, children, property, or pet(s) caused by any of the participating pets, participants, premises or property defects, or other causes. Nonetheless, in consideration of the acceptance of this entry and the allowance of myself, my dog(s) and/or my children's participation in Pooch Plunge, I, for myself and my children, and all others who might otherwise make claim on behalf of me or my children, do hereby voluntarily assume full and sole responsibility for any injury, illness, or damage, accidental or intentional, which may occur to myself, my children, property, or pets directly or indirectly as a result of or during my or my children's participation in Pooch Plunge. Further, I, do hereby forever waive, release, discharge, and hold harmless the City of Lompoc Parks and Recreation, and all sponsors, vendors, staff, and officials from any and all claims, demands, actions and cause of action whatsoever including, but not limited to, any injury, illness, or damages to myself, my children, property, or pets which might result directly or indirectly from or during my, my pets or my children's participation.

### Code of Conduct

The first concern of all Aquatic Center staff is the safety of our patrons. In order to maintain the highest level of safety, we request that all patrons abide by the code of conduct set out below:

1. Children under the age of 8 must be accompanied and supervised by a person age 16 or older. **All children under 7 must remain within arm's reach of a parent or guardian 16 years or older at all times.**
2. All patrons must be attired in a swimsuit. For the safety of our patrons, swim diapers are required. Regular diapers are prohibited.
3. Admission to the facility may be denied for any of the following reasons:
  1. Suspicion that the patron is under the influence of alcohol or drugs
  2. Evidence that a patron has a contagious disease
  3. Evidence of open wounds
  4. Patron not having proper swim attire
4. Abusive or profane language to patrons or the Aquatic Center staff is unacceptable. You will be asked to leave if you use abusive or profane language.
5. Cigarettes, chewing tobacco, alcoholic beverages, lighters and illegal substances are prohibited inside the facility. Electronic Cigarettes are also prohibited throughout the facility.
6. Please refrain from chewing gum in the Aquatic Center.
7. Please refrain from bringing glass containers and alcoholic beverages.
8. Running, dunking, riding on shoulders, fighting, rough play, pushing and shoving, excessive splashing or towel popping is not



allowed in the Aquatic Center.

- 9. For your safety, flips and back dives are not allowed from sides of pool. No diving.
- 10. Patrons must stay off the lane ropes, safety lines and lifeguard stands.
- 11. Loitering is not permitted in or around the Aquatic Center, including the parking lot.
- 12. Large water guns, large floating devices and water wings are prohibited. Water noodles and water toys are permitted. Life Jackets are provided at no additional charge.
- 13. Snorkels and masks are prohibited.
- 14. Only employees are permitted in the office, filter area, mechanical room and storage areas.
- 15. Patrons are asked to refrain from sitting or hanging on lifeguard stands. Talk to the lifeguard only if there is an emergency or assistance is needed. All other questions or concerns can be answered in the office.
- 16. All patrons must obey the rules and regulations listed above and follow the instructions of the lifeguards and The Wet Zone employees.
- 17. The pool employees may eject and suspend any person from the Aquatic Center property for violation of pool rules or for any other action detrimental to the safe and orderly operation of the facility. In case of serious misconduct the City of Lompoc Police Department will be called.
- 18. No tents or umbrellas.

**I fully understand and agree that failure to fully comply with any and all obligations outlined in this Pooch Plunge Attendee Agreement and Waiver, will result in my removal from the Aquatic Center and forfeiture of my entrance fee.**
