A Resolution of the City Council of the City of Lompoc,
County of Santa Barbara, State of California,
Amending the City Compensation Plan (Rule IV) to Include
Revised Salary Ranges Impacted by the State Minimum Wage Increase
And Approving Supplemental Appropriations

- **WHEREAS**, on January 3, 2017, the City Council of the City of Lompoc (City) adopted Resolution No. 6090(17), amending the City's Compensation Plan to incorporate the California State minimum wage increases from January 1, 2017, through January 1, 2022; and
- **WHEREAS**, on December 6, 2022, the City Council adopted Resolution Nos. 6552(22) and 6612(23), amending the City's Compensation Plan to incorporate the State mandated minimum wage increases effective January 1, 2023, and January 1, 2024, respectively; and
- **WHEREAS**, on August 1, 2024, the Department of Finance announced that the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) had increased by 3.18% over the previous year, remaining below the legal adjustment cap of 3.5%, leading to the required adjustment of the State minimum wage; and
- **WHEREAS**, effective January 1, 2025, the minimum wage will increase to \$16.50 per hour; and
- **WHEREAS,** the City Council desires to approve the salary adjustments and revised salary ranges for those part-time, at-will, temporary positions affected by the State minimum wage mandate; and
- **WHEREAS**, the City's Compensation Plan must be amended to include the revised salary ranges as depicted in Exhibit A; and
- **WHEREAS**, Rule IV, Section 1 and 2 of the Personnel Rules of the City provide for the adoption, amendment, and revision of the Compensation Plan; and
- **WHEREAS**, the City Council desires to amend the Compensation Plan to include the revised salary ranges for part-time, at-will, temporary positions, and
- **WHEREAS**, the City Council also desires to approve supplemental appropriations to fund the minimum wage increase.
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
- **SECTION 1.** The Compensation Plan, designated as Exhibit B in Personnel Rule IV, Section 1 is hereby amended to include the revised salary ranges, as outlined in Exhibit A attached hereto.
- **SECTION 2.** The City's Salary Schedule is hereby approved and amended to incorporate the revised compensation, as outlined in Exhibit A, effective January 1, 2025.

SECTION 3. The City Council approves supplemental appropriations to the FY 2024-25 budget due to the minimum wage increase as indicated in Exhibit B attached hereto.

SECTION 4. Effective Date. This Resolution is effective upon its adoption. The salary rate adjustments for the remaining Budget Fiscal Year 2024-25 will be effective the payroll period beginning December 28, 2024, which includes the mandated January 1, 2025, minimum wage increase effective date.
