The City of Lompoc is the Lead Agency and prepared an Environmental Impact Report (EIR) for a comprehensive update of the City's General Plan. The EIR was submitted to the State Clearinghouse and assigned SCH No. 2008081032 (Planning Division File No. GP 07-04, EIR 09-01). The EIR was certified by the Lompoc City Council on October 19, 2010. Although the EIR Addendum does not require circulation, in the interest of full disclosure and public participation, the City of Lompoc is adhering to the review standards of a circulated document and is distributing this Draft EIR Addendum for public review.

Project Location: The City of Lompoc is located in northern Santa Barbara County

Project Description: The City of Lompoc has prepared a comprehensive update to the City's Zoning Code originally adopted in 1974. The primary objectives for the project include implementation of the City's General Plan, compliance with legal requirements, development of clear and enforceable regulations, creation of a modernized, user-friendly Zoning Code, and to address stakeholder input received during public outreach on the Zoning Code Update from 2015 through 2018.

Issues Discussed in Addendum:

The analysis of Greenhouse Gas emissions and Utilities and Service Systems based on current conditions and changes proposed in the Initial Study.

Public Review Period: Beginning August 10, 2018 and ends on September 10, 2018
