1. DR 14-03 – Sign Program Amendment

A request by Lisa Whitman representing Flower Valley Plaza, LLC, the project applicant, for Planning Commission review and consideration of amendments to an approved sign program (DR 14-03). The proposed amendments apply to the number and type of onbuilding and ground mounted signs for tenants of the shopping center located in the *Planned Commercial Development (PCD)* Zoning District at 1133, 1137, and 1145 North H Street (APN: 089-011-016, -017, and -018).
