A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Approving Supplemental Appropriations for the Design of the Transit Operations/Fleet Maintenance Facility Project

WHEREAS, on June 4, 2013, the City Council of the City of Lompoc (City) adopted Resolution No. 5851(13) authorizing City staff to amend the City's Proposition 1B fund application to include the development of a new transit maintenance and operations facility; and

WHEREAS, on March 17, 2015, the City Council directed staff to apply for and program Proposition 1B, Transportation Development Act (TDA), and Federal Transportation Administration (FTA) section 5307 funds for the Transit Operations and Fleet Maintenance Facility Project (Project) and to develop a project financing plan to fully fund the Project from the above listed sources; and adopted Resolution No. 5972(15) Establishing Official Intent to Reimburse Certain Transit Fund Expenditures from Proceeds of Indebtedness in order to cover Project costs until such costs are reimbursed from the above listed funding sources; and

WHEREAS, on March 17, 2015, the City Council also authorized the execution of a design contract for the Project with IBI Group, in the amount of \$639,450 and the execution of contract amendments for an aggregate amount not to exceed \$61,000; and

WHEREAS, "value engineering" consulting services not initially included in the design contract are now considered essential to the Project in order to (i) maintain the function and quality of the Project, (ii) meet the original estimated total Project cost of \$13,000,000, and (iii) combat the increased construction inflation estimates, which have now grown to 6%-8% per year compared to the 1.5%-3% growth rate originally projected for the Project, producing an approximate 15% cost increase from the initial Project cost estimate provided to the City Council, and

WHEREAS, the City Council now desires to provide for the completion of the design work by amending the design contract for the Project with IBI Group, in the amount of \$80,760 and the execution of contract amendments for an aggregate amount not to exceed \$15,000; and

WHEREAS, the City Council now desires to appropriate funds to provide for the completion of the project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
