

**Ordinance No. 1635(17)**

**An Ordinance of the Council of the City of Lompoc,  
County of Santa Barbara, State of California,  
Re-Establishing Speed Limits on Certain Streets**

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC DOES HEREBY ORDAIN AS FOLLOWS:**

**SECTION 1.** Pursuant to its powers under the California Vehicle Code and Lompoc Municipal Code section 10.04.020, the City Council of the City of Lompoc does hereby re-establish, on the basis of engineering and traffic surveys, the following speed limits as designated:

<u>STREET</u>	<u>SPEED LIMIT</u>
Central Ave. – Western Ave. to 300’ west of “V” St.	55 MPH
Central Ave. – 300’ west of “V” St. to “O” St.	45 MPH
Central Ave. – “O” St. to “H” St.	45 MPH
Central Ave. – “H” St. to “A” St.	45 MPH
Cypress Ave. – “O” St. to “H” St.	30 MPH
Cypress Ave. – “H” St. to “A” St.	30 MPH
Cypress Ave. – “A” St. to Third St.	30 MPH
Cypress Ave. – Third St. to Seventh St.	35 MPH
Laurel Ave. – “V” St. to “R” St.	35 MPH
Laurel Ave. – “R” St. to “O” St.	35 MPH
Laurel Ave. – “O” St. to “H” St.	35 MPH
Olive Ave – Bailey Ave to “U” St.	40 MPH

**SECTION 2.** The provisions of each ordinance that are in effect upon the effective date of this Ordinance and that establish speed limits for the above street segments (the “Previous Provisions”) are hereby repealed; provided, that such repeal shall not affect or excuse any violation of the Previous Provisions that occurred prior to the effective date of this Ordinance, nor shall such repeal impede, impact, or negate any administrative, civil, or criminal enforcement that occurred prior to the enforcement date of this Ordinance.

**SECTION 3.** This Ordinance shall take effect 30 days after its adoption. The City Clerk, or her duly appointed deputy, shall attest to the adoption of this ordinance and shall cause this ordinance to be posted in the manner required by law.
