

RESOLUTION NO. 6119(17)

**A Resolution of the Council of the City of Lompoc,
County of Santa Barbara, State of California,
Approval of the Fiscal Year 2017-18 Budgets for
CDBG and Human Services Funds,
Supplemental Appropriations, Necessary Certifications
and Authorizations Required by HUD**

WHEREAS, the Housing and Community Development Act of 1974, as amended, provides for assistance to local governments to develop programs which create viable urban communities; and

WHEREAS, the City of Lompoc (City) received notification from the U.S. Department of Housing and Urban Development (HUD) of the Fiscal Year (FY) 2017-18 allocations for Office of Community Planning and Development's (CPD) formula programs, which provide funding for housing, community and economic development activities, and assistance for low- and moderate-income persons and special populations across Santa Barbara County; and

WHEREAS, the City's FY 2017-18 Community Development Block Grant (CDBG) estimated available amount is \$420,000; and

WHEREAS, a 30-day public review and comment period (April 10, 2017- May 10, 2017) was noticed to the public in the Lompoc Record newspaper on April 10, 2017. A public hearing was held on May 16, 2017, to obtain public comments and proposals for inclusion in the 2017-2018 Lompoc Annual Action Plan; and

WHEREAS, at the City Council meeting of May 16, 2017, Council took public testimony on the Draft 2017-2018 Lompoc Annual Action Plan.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Lompoc FY 2017-18 CDBG Budget (Summary Budget attached hereto as Exhibit "A") is hereby adopted.

SECTION 2. The Lompoc FY 2017-18 CDBG Budget (Line item Budget attached hereto as Exhibit "B") is hereby adopted.

SECTION 3. To comply with requirements of the 2017-2018 Lompoc Annual Action Plan and to properly administer the CDBG and Human Service funds on behalf of the City, the City Manager, or his designee, is hereby authorized to execute all necessary agreements, documents, and certifications (including, but not limited to, loan documents, demand statements, default notices, foreclosure actions, reconveyances,

subordinations, loan workouts, assumptions, promissory notes, deeds of trust, escrow documents, Request for Release of Funds Form #HUD-7015.15, federal environmental review documents, and Section 108 loan documents).

SECTION 4. Effective Date. This Resolution is effective on the day of its adoption.
